Lecture slides are described as a bit dry. The majority of the class struggle with practical's due to the wording of the description sheets. The standard of code presented in the example sheets is not adequate. There has been no consistency in the recording of lectures. Not enough material has bee covered or practised prior to the class test.

Content is good. Practical's are over crowded leading to there being no time to ask for help or get checkpoints checked off. This could be solved through the addition of a second practical time slot of the introduction of more supervisors.
CSCU9YH
Very satisfied with lectures to the point where there are not enough lectures. The Lecture/Practical system could be improved by having a lecture followed by a practical rather than lecture, lecture, practical. The flawed system has led to practical's being off pace with lectures. The content of the practical's needs to be updated.

Lectures are heavily focused on how to use the internet to research rathe than determining the quality of the research found. The module is too broad and unnecessary. An outlined tip sheet would be useful for students to read through themselves in their own time. Individual office hours should be made available to speak to the lecturer about specific problems.
